Regarding the cultural education for dealing with the receipt of the US grant

Decisions on policies of relief organizations and religious organizations

(Adopted at the 65th meeting of the GAC on December 29, 1950)

The sixty-fifth government affairs meeting of the Central People's Government's Administrative Council listened to the report of Vice Premier Guo Moruo on the policy of dealing with cultural and educational relief agencies and religious organizations receiving subsidies from the United States, agreed unanimously, and instructed the Cultural and Educational Committee of the Administrative Council to follow this policy, in conjunction with the relevant departments, quickly formulate implementation measures and fully realize them. The Government Council calls on the people's governments at all levels, all democratic parties, all people's organizations, and people from all fields of culture, education, relief, and religion across the country to work together with patriotism in order to thoroughly realize the goals proposed by Vice Premier Guo in his report. The glorious mission is to strive for the complete eradication of the cultural invasion and influence of American imperialism in China.

## Receive foreign subsidies and cultural education operated by foreign capital

Regulations Relief Organizations and Religious Organizations Registration

(Adopted at the 65th meeting of the GAC on December 29, 1950)

Article 1 This regulation is specially enacted for the purpose of facilitating the management of cultural and educational relief agencies and religious groups that accept foreign subsidies and foreign capital.

Article 2 The cultural and educational relief agencies and religious organizations that accept foreign subsidies and foreign investment as mentioned in this Act include agencies that are run by Chinese people receiving foreign subsidies or annual donations, and directly operated by foreigners or foreign associations. group:

A. Institutions of higher learning, middle schools, elementary schools, kindergartens, schools for the blind and dumb, and other educational undertakings.

- B. Hospitals, sanatoriums, leprosariums, medical teams and other medical institutions.
- C. Religious organizations and their affiliated enterprises.
- D. Orphanages, nursing homes, nurseries and other social relief agencies.
- E. Newspaper offices, printing houses, publishing houses and bookstores.
- F. Libraries, museums and other cultural undertakings.
- G. Various cultural and educational groups and research institutions.

Article 3 The various business agencies and organizations mentioned in the previous article shall, in addition to complying with government regulations and the nature of their businesses, undergo general registration with their competent authorities (such as school and hospital registration, association registration, industrial and commercial registration, etc.) In addition, special registration shall be carried out with the local provincial (city) people's government in accordance

with these regulations. The registration content mainly includes the nature of the business, name, address, name, age, nationality and resume of the host, source and amount of funds and allowances, use of funds and allowances, job content and conditions, etc. The specific items will be stipulated separately.

Article 4 In order to carry out the above-mentioned registration work, the people's governments of each province (city) shall set up special registration offices for cultural and educational relief agencies and religious organizations that accept foreign subsidies and operate with foreign capital.

Article 5 All business agencies and groups that fall under the provisions of Article 2 of this Act shall strictly abide by the common program and various government laws and regulations, shall not conduct activities that violate the interests of the Chinese people, and must implement the following regulations:

A. Every six months, a written report shall be made to the local provincial (city) people's government to take over foreign subsidies and foreign-funded cultural and economic institutions and special registration offices for religious organizations, reporting their work and economic conditions.

B. In case of funds movement or transfer, and receiving foreign remittances, the competent government agency and the special registration office of cultural and educational relief agencies and religious organizations that accept foreign subsidies and foreign-funded operations shall be reported in advance.

Article 6 Anyone who violates the provisions of Article 5, or conceals or fails to report, or reports falsely, may be punished by the local provincial (city) people's government after verifying the facts. If the circumstances are serious, the people's government at the next higher level may Approved to be taken over, reorganized or closed.

Article 7 The registration stipulated in this Act shall be terminated three months after the promulgation of this Act, and those who fail to report within the time limit shall be punished by the local people's government after verification.

Article 8 All cultural and educational relief agencies and religious groups that have registered in accordance with this Act may apply to the provincial (municipal) people's government to cancel their cultural and educational organizations that accept foreign subsidies and operate with foreign capital after they have severed their ties with foreign countries. Registration at specialized registration offices for educational relief agencies and religious groups.

Article 9 The implementation measures of this Act shall be stipulated separately by the Culture and Education Committee of the Government Affairs Council.

Article 10 These Regulations shall be promulgated by the Central People's Government Administration Council for implementation.
