Unified Registration Measures for the Unemployed

(Approved by the Central People's Government Administration Council on August 27, 1952)

Labor and Employment Committee of the Central People's Government Administration Council

Article 1 In order to fully understand the situation of various unemployed persons, so as to deal with them in a planned and step-by-step manner, and to realize labor employment, it is necessary to carry out unified registration of unemployed persons, and these measures are specially formulated.

Article 2 In all large and medium-sized cities where labor and employment committees have been established in accordance with the decisions of the Central People's Government Administration Council on labor and employment issues, the registration of unemployed persons shall be uniformly controlled by the labor and employment committees. A registration office for unemployed persons shall be set up under the Municipal Labor and Employment Commission, and registration sub-offices may be set up in different areas as needed to handle the registration work.

In cities without labor and employment committees, the registration of a small number of unemployed persons can be handled by the relevant departments of civil affairs, labor or culture, and the registration results will be reported to the provincial labor and employment committee.

Article 3 In addition to a small number of full-time cadres, the registration authority for unemployed persons may report to the local labor, personnel, civil affairs, public security, education, finance and other relevant departments by the labor and employment committee according to actual needs when handling the registration work unexpectedly. And relevant groups such as trade unions, women's federations, and federations temporarily transfer cadres to participate in the work.

Article 4 The scope of registration of unemployed persons is as follows:

1. Workers and employees who were engaged in physical or mental work in public and private industrial and commercial enterprises, transportation, transportation enterprises, handicraft workshops, institutions, organizations, and schools, as well as construction workers and porters who have no fixed employer, have no fixed occupation after unemployment;

2. All workers engaged in seasonal industries whose industries have declined and cannot find workers;

3. Unemployed intellectuals with a junior high school education or above, and unemployed former military officers and officials who have difficulties in life and require employment;

4. Independent producers, merchants and street vendors, management agents, and small industrial and commercial owners who have suspended their work and business, do not have other income, live in difficulty, and require employment as wage laborers;

5. Other unemployed persons who have difficulties in life and require employment.

The above-mentioned unemployed persons are limited to those who have fixed household registration in the city where the registration is carried out. Unemployed workers and employees who live in staff dormitories but are not registered in their household registration can register if they have a trade union certificate.

Article 5 The following persons shall not be registered temporarily:

1. Those who have no fixed job for a long time, but have other income or support from relatives, and their life can be maintained;

2. The in-service personnel request to change jobs or transfer factories or locations;

3. Workers and employees engaged in seasonal industries who stop working during nonproduction seasons;

4. Current students who request to leave school as job seekers;

5. Those who have returned to the countryside from the city and have been properly resettled.

Article 6 All unemployed persons who apply for registration shall, in addition to submitting their household registration certificates or household registration certification letters, also submit and verify the following documents held by them:

1. Unemployed workers and employees should submit for inspection the certification documents issued by the original trade union organization or work unit;

2. Unemployed intellectuals, former military officers, and former officials should submit their academic qualifications and seniority certificates for inspection;

3. Independent producers and small industrial and commercial owners should submit for inspection the certificate of closure issued by the industrial and commercial management department and the Federation of Industry and Commerce (or trade association); traders and vendors should submit for inspection the certificate of closure of the management agency they belong to; the agent of the capital should submit the original for inspection Certificate of resignation of the enterprise unit;

4. Other certification documents held by other unemployed persons.

Article 7 Any unemployed person who applies for registration must fill out an application form for registration of unemployed persons, and after passing the examination, the Municipal Labor and Employment Committee will issue a registration certificate.

Article 8 Anyone who has registered at the local unemployed workers' relief agency, labor agency or unemployed intellectuals' registration agency but has not yet been employed must renew his registration certificate. If you do not renew, it will be treated as employment, and the original application registration form will be cancelled.

Article 9 After registration, unemployed persons shall declare to the original registration authority when they temporarily leave the original registration area or change their residence in the city. If you move to another city, you must go through the transfer registration procedures. Those who have been employed and returned to their jobs shall hand in their registration certificates for cancellation.

Article 10 The registration agencies for unemployed persons established by the labor and employment committees of each city shall be canceled immediately after the comprehensive and unified registration of unemployed persons is completed. In the future, regular registration work shall be continued by the labor department in accordance with the provisions of these Measures.

Article 11 Local labor and employment committees may formulate implementation rules in accordance with these measures.

Article 12 These Measures shall be promulgated and implemented after being approved by the Central People's Government Administration Council.
