Zhou Enlai: on the changes in the organization and tasks of the People's Government of the Greater Administrative Region (Military and Political Committee), the adjustment of provincial and district organizational systems, and the establishment of additional Central People's Government institutions **Other Decisions and/or Actions:**

<u>Decision on the Change in Structure and Tasks of People's Governments (or Military and Administrative Commissions) in Administrative Regions</u>

State Planning Commission installed Its members were: Kao Kang (chairman), Teng Tzu-hui (vice-chairman), Chen Yun, Peng Teh-huai, Lin Piao, Teng Hsiao-ping, Jao Shu-shih, Po I-Po, Peng Chen, Li Fu-chun, Hsi Chung-hsun, Huang Ke-cheng, Liu Lan-tao, Chang Hsi, An Tzu-wen, Ma Hung, and Hsueh Mu-chiao.

Remarks:

- 1. The people's government or military and political committees of large administrative regions shall be changed to administrative committees. The Regional Administrative Committee is an agency that represents the Central People's Government in leading and supervising local governments in each region. The chairman, vice-chairmen and main administrative personnel of the regional administrative committee shall be appointed and removed by the Central People's Government Committee upon request by the State Council.
- 2. The four sub-committees and general offices of the political and legal, financial and economic, cultural and educational, and people's supervision that originally belonged to the people's government or military and political committee of the large administrative region are still retained and changed to the political and legal committee of the administrative committee, the financial and economic committee, and the cultural and education committee, People's Supervision Committee and General Office.
- 3. After the establishment of the administrative committee, all the ministries under the former people's government (military and political committee) of the large administrative region will be changed to bureaus (divisions), and some of the bureaus (divisions) will be directly taken over by the central competent departments. From then on, the bureaus (divisions) set up in the region are divided into two types in terms of business leadership: one is led by the regional administrative committee or under the guidance of the administrative committee's political and legal, financial, cultural and educational committees; the other is governed by Directly led by the central competent departments, they have become a number of professional administrations (divisions) established by the central departments in the region. The organization belongs to the central competent department and is under the guidance and supervision of the regional administrative committee and its relevant subcommittees.

- 4. The organizations of the branches of the Supreme People's Court and the Supreme People's Procuratorate of the Greater Administrative Region will remain unchanged. The relationship of the Law Committee is the same.
- 5. The People's Government of the Greater Administrative Region (Military and Political Committee) shall immediately formulate implementation measures based on this decision in combination with specific conditions. However, the bureaus (divisions) that should be established and added by the administrative committees of the various regions and the bureaus (divisions) that should be taken over by the various ministries of the Central People's Government must be made by the various regional people's governments (military and political committees) in consultation with the central ministries to propose specific plans, together with the establishment The population report can only be implemented after approval by the Central People's Government Administration Council.
- 6. This reorganization should be completed by the end of 1952 at the latest.
