(2) People's governments at all levels across the country should immediately organize discussions among the people on the draft constitution, explain to the people extensively the contents of the draft constitution, and mobilize the people to actively propose amendments to the draft constitution.

(3) The Constitution Drafting Committee should continue its work, collect the opinions of the people, conduct research, complete the amendment of the draft constitution before the first meeting of the First National People's Congress, and prepare to submit the draft constitution to the National People's Congress.
